MEMBERSHIPS

Family Membership: Entitles the member, spouse and at-home children, under IS, to unlimited hunting and invitations to all events. Voting rights are limited to one vote per membership.

Individual Membership: Entitles the member to unlimited hunting and invitations to all events. Non-hunting spouses and family members of this membership will also be included in the roster and are welcome to all events. Voting rights are limited to one vote per membership.

Mid-Hunter: Mid-Hunter members are included in all social events, entitled to hunt any eight days without a capping fee and two additionally days with a capping fee to be paid that day. Joint meets are allowed.

Membership & Capping Payments may be credited against Membership Upgrades during Hunt Season **Social Membership:** Includes all social events by invitation, entitled to hunt any three days without a capping fee and two additional times with a capping fee to be paid that day. Joint meets are allowed.

Intermediate Membership: Entitles the married or single member who is at least 21 years of age and not yet 30.

Non-riding Membership: Grants member access to all Santa Fe Hunt activities exclusive of riding to hounds. (Non-riding Memberships may upgrade to riding member.)

Professional Membership: Professional members enjoy unlimited hunting and invitations to all events. Professional memberships are for trainers, veterinarians and farriers who use their skills to provide a service to the club and its members. These memberships are defined and granted at the discretion of the Board of Directors.

☐ Out-of-State Membership:\$95.00/\$98.00* receives all Santa Fe Hunt newsletters, invitations, and other mailings.					
☐ Junior Membership : \$285.00/\$294.00* entitles unmarried junior member, who is at least 12 years of age, but not yet 21, to unlimited hunting as long as a responsible adult accompanies them.					
□ Non-Resident Membership: \$500.00/\$515.00: Available to full-hunting members of another MFHA recognized hunt. This membership carries the same privileges/obligations as a full hunting membership, except voting rights and presentation of awards are excluded.					
☐ Young Hunter: Unlimited hunting for individuals 12 & under, as long as accompanied by a responsible adult. No cost.					
☐ Professional: \$515.00/\$530.00*: Granted by Board of Directors to equestrian professionals (includes MFHA fee).					
☐ Patron Enhancement: Any member designated as a "Patron" and will receive recognition and thanks for this contribution.

VOTING MEMBERSHIPS					
☐ Individual Membership: \$2,150, includes MFHA Fee. Membership entitles the member to unlimited hunting and invitations to all events. Non-hunting spouses and family members of this membership will also be included in the roster and are welcome to all events. Voting rights are limited to one vote per membership.					
☐ Family Membership: \$3,025, includes MFHA Fee. Membership entitles the member, spouse and at-home children, under IS, to unlimited hunting and invitations to all events. Voting rights are limited to one vote per membership.					

Capping Fees

Formal Hunts (weekend): Adults = \$150; Juniors = \$50; Pony Club Member free . **Informal Hunts (weekday) & Autumn Hunting:** Adults = \$75, Juniors = \$35, Pony Club Member free.

A guest may cap twice per season; thereafter, membership is required. Capping Fees may be credited toward membership.
